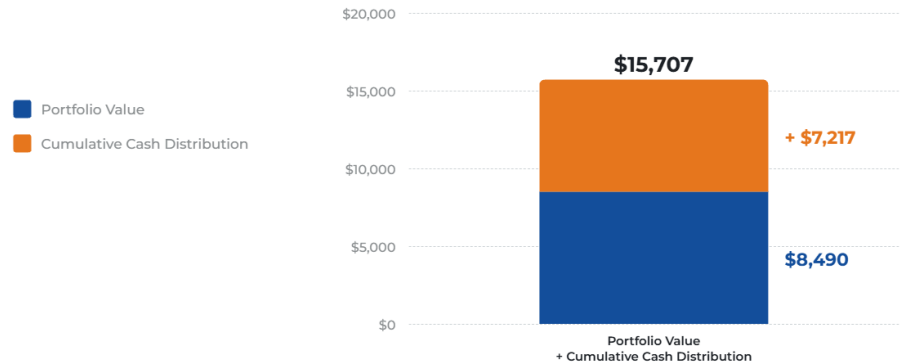

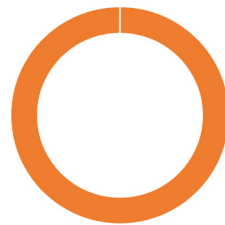
NAVS AND DISTRIBUTIONS SINCE INCEPTION
