Active management in Canadian preferred shares continues to be an attractive investment opportunity. ## General Industry Update

Most equity markets broadly rallied during the month of October, with the exception being the growth heavy NASDAQ Index. The market remains hopeful that large interest rate increases are nearing an end. Many will suggest that earnings are good without considering the magnitude of negative revisions to Q3 forecasts coming in. Markets have a tendency to perform well during earnings season and that performance tends to be even stronger when pessimism is high coming in as it was today. Fixed Income markets on the other hand continued to see yields rise which resulted in negative total returns for short, mid, and long-term bonds.

Despite this "risk-on" environment, the Canadian Preferred Shares market declined -0.8% during the month of October, as a result of rising bond yields, bringing the YTD performance to -16.1%

In this current market being defensive and overweight Fixed Resets with low rate reset spreads contributed positively to the portfolio, as did securities with low duration which acted defensively in the rising interest rate environment.

We have been adding Fixed Resets with a high likelihood of being called and adding to Banks. We are overweight in P-2 rated securities, and focusing on issuers with strong fundamentals.

## Outlook

- Higher expected interest rates and volatile credit environment
- Low supply and redemptions are expected to continue in 2022
- More issuance of OTC preferred shares, but minimal
- LRCN market needs to remain open
  - LRCN investment grade ratings need to continue
- Expect less price return and more return from dividend income
  - Expect negative returns in 2022, as a result of credit spread widening
