WHAT DOES THE ETF INVEST IN?

The ETF seeks to provide holders of Units with a high level of current income through monthly distributions. Under normal market conditions, the ETF invests primarily in a diversified portfolio of below investment grade corporate debt securities rated “BB+” or lower by Standard & Poor’s Rating Services (“S&P”) and Fitch Ratings (“Fitch”) or “Ba1” or lower by Moody’s Investor Services, Inc. (“Moody’s”) at the time of investment. The portfolio will generally have an average duration of less than three years.

HOW RISKY IS IT?



Like mutual funds, ETFs have a NAV. It is calculated after the close of each trading day and reflects the value of an ETF's investment at that point in time.
