### Carbon Clock

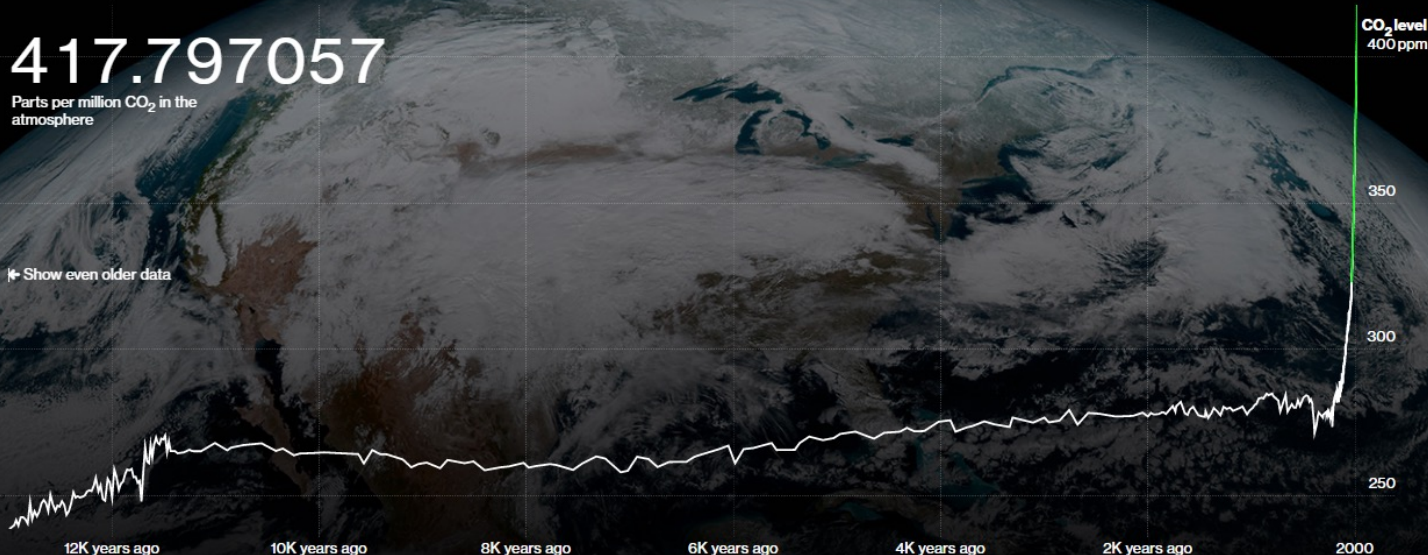
