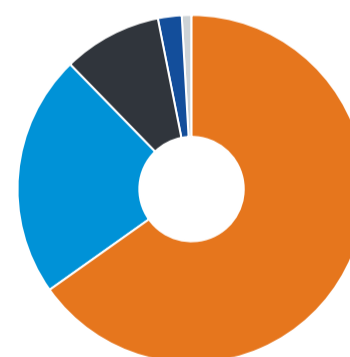
Geographic Allocation
