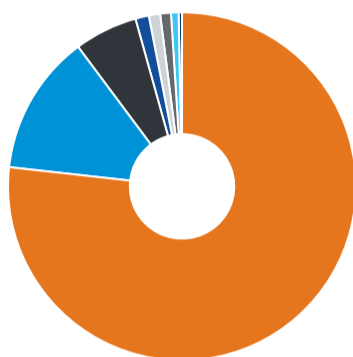

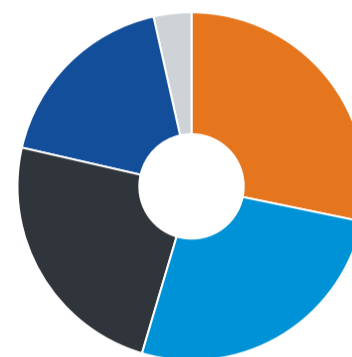
Geographic Allocation
