### WHAT DOES THE FUND INVEST IN?

The fund seeks to replicate, to the extent reasonably possible before fees and expenses, the performance of the Solactive Global Healthcare 20 Canadian Dollar Index Hedged, or any successor thereto, while mitigating downside risk. The fund invests primarily in the equity constituents of the Solactive Global Healthcare 20 Canadian Dollar Index Hedged, or any successor thereto, while writing covered call options on up to 33% of the portfolio securities, at the discretion of the Manager. The level of covered call option writing may vary based on market volatility and other factors.



## A WORD ABOUT TAX

### More about the trailing commissions

The trailing commission is an ongoing commission. It is paid for as long as you own the fund. It is for the services and/or advice that your representative and/or their firm provide to you. Evolve pays the trailing commission to your representative's firm. It is paid from the fund's management fee and is based on the value of your investment. The rate depends on the sales charge option you choose.

Trailing commission: 1.00% of the value of your investment each year. This equals \$10.00 each year for every \$1,000 invested.
